Promoting Racial Equity in Maternal Health: Maryland's Strategic Plan Development

Bizzell's collaboration with the Maryland Department of Health's Maternal and Child Health Bureau (MCHB) has advanced racial equity in maternal health across Maryland. Working with the Maryland Maternal Health Task Force chair and MCHB, we developed a statewide maternal health strategic plan that embedded antiracist strategies and equity principles into health initiatives. This plan set priorities and outlined strategies to eliminate racial disparities and improve health outcomes for mothers, especially those most affected by inequities. We ensured that maternal health policies and practices are inclusive and equitable. Bizzell significantly transformed Maryland's maternal health landscape toward more racial equity.

Health Resources and Services Administration (HRSA) Coordinating Center for Research to Practice Partnerships (CC-R2PP)

Bizzell manages the HRSA CC-R2PP to bridge research and practice within the Maternal and Child Health Bureau (MCHB), focusing on Research Networks (RN) and Special Interest Interdisciplinary Projects (SIIPs). We assess needs, facilitate collaboration and promote research dissemination to improve maternal and child health outcomes. Our inventories and assessments for RN/SIIPs and MCHB divisions identify collaboration opportunities. We manage a Virtual Learning Collaborative (VLC) for shared learning and strategic alignment among MCHB stakeholders. Additionally, we develop and disseminate resources like newsletters and a Moodle-based learning platform and create a dissemination plan to broaden research.

HRSA Division of Home Visiting and Early Childhood Systems (DHVECS) Technical Assistance (TA)

Bizzell managed the HRSA DHVECS TA contract, conducting data and impact analyses and providing comprehensive technical assistance to 56 grantees across every state and jurisdiction. We facilitated 50 annual site visits, including performance improvement and general TA visits to enhance the delivery of evidence-based home visiting programs for families in at-risk communities. We implemented a programmatic and financial assessment tool and developed a TA website for effective communication and support. Additionally, we created and distributed TA training manuals, grantee educational resources, site visit reports, and a Maternal, Infant, and Early Childhood Home Visiting (MIECHV) consultant newsletter. Our logistical support for TA consultants included webinar trainings, travel arrangements, and financial processing.

HRSA Enhancing HIV Care of Women, Infants, and Children and Youth (WICY) Building Capacity Through Communities of Practice (CoP)

Bizzell established Communities of Practice (CoP) to enhance the HIV workforce serving women, infants, children, and youth (WICY). We implemented evidence-based interventions to improve outcomes, focusing on youth transitioning to adult HIV care, trauma-informed care, and pre-conception counseling. We facilitated collaboration among HRSA HIV/AIDS Bureau divisions, Ryan White HIV/AIDS Program Part D recipients, and public health partners to share HIV quality improvement methodologies and best practices. Managing three 12-month CoPs, providing technical assistance, developing assessment tools, and tracking progress, Bizzell improved family-centered services for WICY affected by HIV and disseminated innovative strategies and provided an implementation toolkit with resources and tools used by CoP teams.

HRSA Title V Maternal and Child Health (MCH) Block Grant Program Support

Bizzell enhances the HRSA Title V MCH services block grant program by providing critical grant reviews and technical assistance to 59 states and jurisdictions. We foster family-centered, community-based, and culturally appropriate care systems for mothers, infants, and children, including those with special health care needs. We manage and support regional, in-state and virtual HRSA MCH block grant reviews and offer technical assistance for program planning, goal development, standards of care, evidence-based strategies, measurement and evaluation, and data collection. Through managing consultant databases, TA requests, and logistical support for TA events, Bizzell ensures effective dissemination of materials, coordination of site visits, and facilitation of TA webinars.

HRSA MCHB Sickle Cell Disease Newborn Screening Program Technical Assistance

Bizzell provided technical assistance to the Sickle Cell Disease Association of America (SCDAA) to enhance their capabilities in financial planning, budgeting, cash management, third-party reimbursements, grants management, cost allocation, fiscal reporting and audit compliance, effectively managing their HRSA grant award.
